### **Screening for Life Services**

The Screening for Life (SFL) program is committed to providing important preventative cancer screenings FREE to those who qualify. Since the Community Healthcare Access Program (CHAP) & SFL enrollment integration in summer 2012, all clients currently enrolled in CHAP have been qualified in SFL as well. For patients, this means reducing out of pocket expenses for health services covered by SFL. For providers, this means reimbursement for services. If your practice currently provides clinical breast exams, pelvic exams, cervical pap smears, mammograms, PSA testing or colonoscopy services, please be sure to speak to a SFL case manager about client eligibility prior to scheduling appointments. ### **Changes Coming to the CMS-1500 Claim Form**

The National Uniform Claim Committee (NUCC) has announced the release of a revised 1500 Health Insurance Claim Form (version 02/12) to replace the current form (version 08/05). The form was revised to align the paper form with some of the changes in the electronic claims. The most significant changes were the addition of eight diagnosis codes in Item Number 21 and the addition of the QR Code at the top left of the form.
