Cerner will be loading the *Specialty PM* 2012.1.1 release for your practice during the evening of Thursday, Feb. 28. The updates will be fully available on Friday, Mar. 1.

The 2012.1.1 release contains all updates from the 2012.1 release, as well as some additional enhancements to insurance claims and charge entry, and is mandatory for all *Specialty PM* clients to allow for compliance with the CMS ANSI 5010 and ICD-10 mandates. This release also provides clients the ability to report on additional Meaningful Use data. Please view the training videos (below) and review the attached Flash to learn about the changes associated with the 2012.1.1 release. There will be no downtime associated with this release.

CMS-1500 Claim Form Changes and Transition Dates

The National Uniform Claim Committee (NUCC) has announced the release of a revised 1500 Health Insurance Claim Form (version 02/12) to replace the current form (version 08/05). Transition dates are as follows:

June 1 – October 1, 2013 – Practices can use either the current form or the revised form. Health plans, clearinghouses and billing vendors will accept and process either version of the form.

October 1, 2013 – The current form is discontinued, and only the revised form is to be used. This includes all rebilling of claims.

Completing the State Mandatory Training Program

The State of Delaware is required to provide mandatory training on the recognition of child sexual and physical abuse, exploitation, and domestic violence and the reporting obligations under the Medical Practice Act. An online training program has been created by the State and is available for physician access to satisfy the mandatory training requirement. This training must be completed by all Delaware licensed physicians each license renewal period. The current medical license renewal deadline is March 31, 2013.
