August is National Immunization Awareness Month (NIAM). This annual national health observance provides an opportunity to highlight the need for improving national immunization levels. The Centers for Disease Control and Prevention (CDC) list influenza and pneumococcal as especially serious diseases for adults 65 and older. Accordingly, Centers for Medicare and Medicaid Services (CMS) asks health care professionals to encourage Medicare beneficiaries to stay current on their immunizations, especially seasonal influenza, pneumococcal and hepatitis B for those who are at risk. Medicare Part B covers these immunizations and their administration for qualified beneficiaries.
