Worker's Compensation Changes In Effect

A large number of changes in the Delaware Workers' Compensation Program went into effect September 11, 2013. These include changes in the fee schedule, pharmacy preferred drug list, practice guidelines, utilization review guidelines and forms. Workers' Compensation Education - Also, effective on September 11, 2013, the due date for the next continuing education required for all physicians certified in the Delaware Workers' Compensation program is March 31, 2015, to coincide with medical license renewal. Other health care professionals certified in the program also have their Workers' Compensation continuing education due dates aligned with their licensure renewal dates.

Any physician who was overdue on his or her continuing education requirement prior to September 11, 2013, has been removed from the certified list and must complete a new application for certification and take the continuing education to be certified in the program. IMPORTANT UPDATE - CMS-1500 Claim Form Transition Dates Revised

In June, the National Uniform Claim Committee (NUCC) announced the approval of the updated 1500 Claim Form that accommodates reporting needs for ICD-10. An October 2013 transition timeline was previously announced however, the NUCC approved a new timeline at their August 2013 meeting to align with Medicare's transition timeline.

The revised timeline is as follows:

- January 6, 2014: Payers begin receiving and processing paper claims submitted on the revised 1500 Claim Form (version 02/12).
- January 6 through March 31, 2014: Dual use period during which payers continue to receive and process paper claims submitted on the old 1500 Claim Form (version 08/05). Practices can use old or new form.

- April 1, 2014: Payers receive and process paper claims submitted only on the revised 1500 Claim Form (version 02/12). Only the new form will be accepted.

He is one of the three primary Interventional Cardiologists of the Transcatheter Aortic Valve Replacement (TAVR) team at Christiana Care Health System and has worked diligently in developing the program along with other team members. His special interest lies in complex and high risk coronary interventions such as, Chronic Total Occlusions, and newer technologies including Left atrial appendage closure devices, mitral valve therapies, renal denervation, drug

eluting balloons in the peripheral arteries, and newer stent platforms particularly the Bioabsorbable Vascular Scaffold (BVS) stents.
